# COVID-19 CLEANING/TREATMENT SERVICES

#### LEVELS OF CLEANING/TREATMENT SERVICE

Many of our National Clients are aware of the virus pattern, and we are mitigating the risk of exposure and addressing the potential concern for that particular moment in time. It is challenging to react to each claim of an affected, or assumed to be affected, person entering the business. For this reason, we have developed and presented a two-level approach to the request for service.

#### **LEVEL ONE:**

- Establishing containment of the area, if needed, to prevent cross contamination
- Manually clean all horizontal and vertical surfaces up to 8-10' height using EPA registered disinfectant
- Steam cleaning all carpets and flooring. (optional per customer request)
- Steam cleaning all upholstery. (optional per customer request)

#### **LEVEL TWO:**

- Level One protocol.
- Use of HEPA Filtration and properly placed air scrubbers is recommended.
- Use of misting/ fogging system with appropriate EPA approved solutions, designed to aggressively deactivate any cells that may be remaining anywhere on surfaces and in the air.

## PRODUCTS AND EQUIPMENT

The EPA is steadily updating the list of approved and registered disinfectants known to have efficacy on the target contagion. The CDC makes adjustments to recommendations in response to new studies and information for reducing spread. OSHA issues guidelines for maintaining safety in the ever-changing work environments. DKI/G2 is in constant review of all government recommendations and guidelines as well as participating in independent analysis to determine the best products and equipment for use in the process. Our vendor supply division, DKI ProSupply, is also performing regular assessments of inventory, supply chain movement, and new product availability.
